SECTION 5: Fire-fighting measures

5.1. Suitable extinguishing media

SECTION 6: Accidental release measures

Evacuate area. Eliminate all ignition sources if safe to do so. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Use only non-sparking tools. Ventilate the area with fresh air. For large spill, or spills in confined spaces,

provide mechanical ventilation to disperse or exhaust vapours, in accordance with good industrial hygiene practice. Warning! 6.2. Environmental precautions

6.3. Methods and material for containment and cleaning up
