The International Agency for Research on Cancer (IARC) recently reviewed existing epidemiological data and concluded that crystalline silica inhaled in the form of quartz from occupational sources is a Chronic Effects:

known human carcinogen (Group 1). In making the assessment, IARC noted that carcinogenicity was not detected in all industrial circumstances studies. However, IARC reported that a majority of studies indicated an elevated mortality for lung cancer among silica-exposed workers. IARC noted that increased rates of lung cancer were reported among some workers in oremines, quarries, foundries, ceramics, granite and stone cutting industries. The workers in some of these occupational studies were exposed to other potential respiratory carcinogens such as arsenic, radon, diesel exhaust, polycyclic aromatic hydrocarbons or cadmium. IARC reviewed animal studies and concluded that there is

sufficient evidence in experimental animals for the carcinogenicity of quartz.
