### 2. Hazards identification

#### **Emergency overview**

: DANGER!

#### Over-exposure signs/symptoms

There is some evidence that repeated exposure to organic solvent vapors in combination with constant loud noise can cause greater hearing loss than expected from exposure to noise alone. ### 5. Fire-fighting measures
