SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Get medical advice or attention if you feel unwell or are concerned.

Skin Contact

Wash gently and thoroughly with lukewarm, gently flowing water and mild soap for 5 minutes. Take off contaminated clothing, shoes and leather goods (e.g. watchbands, belts). If skin irritation occurs, get medical advice or attention.
