Based on studies of Stoddard solvent sample 85-01 sponsored by the American Petroleum Institute, the acute dermal LD50 was found to be >3.0 g/kg and the acute oral LD50 was found to >5.0 g/kg. Acute inhalation toxicity tests showed a no observable effect level for inhalation of Stoddard solvent at 4.0 mg/l, with eye irritation and slight loss of coordination at 8 mg/l, and tremors, CNS depression and death within 7.5 hours of exposure to 10 mg/l. In a 28-day dermal study sponsored by the API, moderate skin irritation occurred at 200 mg/kg, with moderate to severe irritation above 1000 mg/kg. DEVELOPMENTAL TOXICITY: In a mouse inhalation study using dose levels of 0, 100, 500, and 1500 ppm for 6 hours/day on gestation days 6-15, no signs of maternal toxicity or developmental toxicity were observed at 100 ppm.
